Subject:	Employment Under a Waiver for Speech Language Pathologist Services Credential
Meeting:	September 29, 2020
Type:	Action
Recommended Action:	It is recommended the Board approve a Variable Term Waiver to cover Katherine Cameron's services as a Speech Language Pathologist until she completes the requirements for the Speech- Language Pathology Credential in May 2022.
Background:	The District ran recruitment for (1) Speech and Language position and a Speech and Language Assistant position, which are considered a statewide shortage area by the California Commission on Teacher Credentialing. Our existing Speech and Language assistant, Katherine Cameron sent over a letter of intent for the position. Katherine Cameron would be eligible for the credential in May of 2022 and is currently enrolled in the program. To cover Ms. Cameron's services until she meet the requirements for the credential, she must apply for a Variable Term Waiver. The California Commission on Teacher Credentialing requires the District to notify the Board that employment for Ms. Cameron will be based on a Variable Term Waiver for the Speech and Language Pathology Services Credential.
Analysis:	The District will comply with state requirements for Variable Term Waivers.
Funding:	No cost to the district.
